# PRESIDENT'S MESSAGE

Dear Friends:

Thanks to a great deal of careful planning and hard work by many Chicago Adlerians and to the dedicated leadership of convention coordinators, <u>Dorothy Peven</u> and <u>Marilyn Eager</u>, NASAP celebrated its 25th anniversary in grand style. Registration for the convention totaled about 600, making the meeting the largest in the history of the Society. The high attendance was a tribute to the Convention Committee members and to the continually increasing interest in the principles and techniques of Individual Psychology.

One of the goals of this Society during the coming year is to encourage the development of strong regional organizations within NASAP. A significant step toward that goal was taken at the Chicago convention, when the three regions that had not been organized elected leaders and established objectives for the coming year.

In order to support the development of activities under regional sponsorship, the D.A. approved a revenue sharing plan whereby the organization that represents one of the Society's regions may request up to \$200 from NASAP to help fund its organization. Requests for such funds should be directed to Barney Lane, Chairman of the Committee on Development, 219 Cordon Road, Wilmington, DE 19803. The requests should include specific plans for the use of the funds.

Each regional organization is encouraged to conduct one or more educational programs in their region this year. The Society is ready to have a good deal of its work carried out through its regional organizations.

# CONVENTION REACTION Chicago, IL, 6-1-77

We had a great convention. I enjoyed it, and an looking forward to participating again. This letter is to record a few suggestions while they're still fresh. It is not to complain, but to share ideas that I think will enhance future meetings.

- 1. Identify people by their home base, both on the program and on name tags. This helps us know one another better, to make connections, and to get a sense of where people are working and with whom. It makes communication among members easier and thus more likely. I believe that is one of our Society's goals.
- 2. More participatory sessions. In the forum I led, we had lots of response from those who attended, and over the period of two hours, I counted 40 people who stayed with us to the end. On the other hand, I attended a session where all but three minutes of the allotted time was used for the presenter to read a paper, and that gets dull. I walked out on another similar reading. If we really want to Share Adlerian Ideas for Living, lets suggest that people read only a synopsis of their papers so that there's time for questions and discussion. Copies of the whole paper could be available for those who want the references and the details.
- 3. The Delegate Assembly works hard for long hours, but the general membership has very little information about what's going on. Since people generally don't like to sit in meetings and listen to reports, let's do a convention newsletter, make copies and distribute them before people go home Sunday. It would contain a report of decisions taken, plans made, new members, etc. The Relay of Region I for May/June did a superb job of reporting on the special March D.A. meeting. I'm glad I'm a subscriber.

I write this as a letter to the editor because I don't know where else to direct my comments. I'd welcome response from other members who read it in the Newsletter.

# DEVELOPMENT COMMITTEE

During the March 19-20, 1977, meeting of the DA in Chicago, a resolution was passed requesting the Regions to organize and to actively promote Adlerian psychology within the Regions. Effective with the DA meeting May 27, 1977, in Chicago, several people accepted the responsibility and we will soon see activity in all Regions. This means setting up some sort of structure that will present to the public annual and semiannual meetings patterned on the national meetings, weekend workshops, development of learning centers, use of regional resources, and other items that will strengthen the Region and educate the public. Regional chairpersons will be seeking your assistance in the near future.

The NASAP Bylaws also offer an opportunity to each of us to help in expanding NASAP across the U.S. and Canada. Five Standing Committees have been formed to implement the business of the Society. They are (a) The Standing Committee on the Constitution - Bob Powers. All questions regarding constitution and Bylaws, elections, ethics,

delinquency, suspension and expulsion. (b) The Standing Committee on Development - Barney Lane. All questions regarding expansion, growth, regional development, and affiliations. (c) The Standing Committee on Public Relations - Richard Berrett. All questions regarding advocacy, public relations, and liaison and other groups, associations and schools of thought in the fields of psychology, education, etc. (d) The Standing Committee on Education - Don Kelly. All questions regarding annual meetings and other meetings of the Society, training workshops, consumer education, accreditation, certification and professional standards and competencies. (e) The Standing Committee on Publications - Janet Terner. All questions regarding scientific development of theory and practice in Individual Psychology, publications and research.

Although each member of the DA is expected to serve on one of these Committees, it is not enough. Each of these Committees needs several members from each of the Regions to help develop and expand the whole society as well as be a mover in the Region. Won't you write the Chairperson of one of the Standing Committees and offer your help. With membership above the 1,000 mark, areas of need identified and responsibility offered and taken, the only remaining ingredient needed to make it all happen is you. Some of you will be able to attend meetings. Some will not. Don't give it a second thought. The mail will carry your thoughts, advice and counsel to the right place. Your Region and NASAP need your help.

# DELEGATE ASSEMBLY

The Delegate Assembly met on Friday, May 27, 1977 at the 25th Annual Convention of the Society in Chicago. This was the trial run for the new working procedure approved by the D.A. at its special meeting in March. The D.A. met in a general session for about an hour and then divided into the standing committees, where matters referred to the committees were discussed and recommendations brought back to the D.A. at a general session in the afternoon. Action items were handled by the D.A. for the remainder of the day. Nominations for officers were made and the election was held on Saturday, May 28, when the nominees made a brief statement of intention. The following are items to be reported from the D.A. meeting.

1. Election Results -- The following were elected for a three-year term and were seated with vote at the D.A. meeting:

- 2. Elected Sylvia Robbins as Region V delegate for one year to fill vacancy caused by only one person being nominated by Region V.
- 3. Membership Report -- First 5 months in 1977 1008 members plus 20 Life Members 1976, full year, 800 plus 20 Life Members.
- 4. Student Membership -- There has been a substantial increase in the number of student members. Of the 1,008 members, 158 are students. The D.A. voted to ask student members to verify their full-time status the second year. A place will be provided on dues notice for verification by a major professor.
- 5. Authorized expenditure of \$200 for NASAP exhibit package to be used at APGA and perhaps other association meetings.
- 6. Computerizing membership records is being investigated.
- 7. Funding -- James McDonough was appointed Special Advisor on Funding and was asked to form a committee. He sees the program as a two-part one. The first is sharing information with the membership via the Newsletter about things that have been done and what is available in the way of funding for projects. The second part is the development of a project for the Society.
- 8. The 1978 semi-annual meeting has been changed from Halloween weekend to November 3, 4, 5, 1978. (No invitation has been received to host the meeting!)
- 9. <u>Hertha Orgler</u>, author of <u>Alfred Adler</u>, the <u>Man and His Work</u>, was elected to Life Membership honoris causa.
- 10. Recommended that the Election Committee excerise its power in the future to nominate candidates for D.A. for any region for which a nomination is not forthcoming.
- 11. Constitution Committee has prepared a working draft of a new Constitution and separate By-Laws. The D.A. will vote on the two documents by mail during the summer and they may be submitted to the membership for ratification in the fall.
- 12. Authorized funds to be made available up to \$200 per region for 1977 in order to encourage regional development. (see President's Message)

# Of General Interest, Delegate Assembly cont'd

- 13. "How to" book is being prepared by Development Committee for use by Regions to help in organizing process.
- 14. It was recommended that regional boundaries be reviewed, rearranged and acted upon. It was suggested that this matter be discussed at regional meetings and referred to October D.A. meeting.
- 15. The Education Committee has been asked to develop a colorful brochure about NASAP for promotional and public relations use.
- 16. It was recommended that the Executive Committee appoint a press officer to assume responsibility for publicity for each semi-annual meeting and annual convention.
- 17. Approved proposal to promote use of acronym, SAIL (Sharing Adlerian Ideas for Living) by local, area and regional groups. It will be tested by a few groups before an official launching at Washington convention in 1978.
- 18. It was recommended that the present practice for semi-annual meeting be continued; that is, that it be both a working meeting for D.A. and a professional conference. D.A. members will not participate in the conference programs until Saturday afternoon so that they will be available for D.A. meeting.
- 19. It was recommended that a special symposium be established for annual and semi-annual meetings which will focus specifically on the relationship between theory and practice in Individual Psychology.
- 20. It was recommended that pre-convention workshops be instituted on a regular basis at annual and semi-annual meetings when financially and logistically possible, but D.A. members will not be participants.
- 21. It was recommended that a statement be summarized for new D.A. members regarding the structure of NASAP and responsibilities of Delegates.
- 22. It was recommended that the profits for the annual and semi-annual meetings and workshops continue as in the past: Post Convention Workshops profits to NASAP; Pre-convention workshops profits 50-50; Annual meeting 75% NASAP, 25% host; Semi-annual meeting 100% host.
- 23. It was recommended that the Society initiate an active campaign for research/evaluation of F.E.C.'s and study groups.
- 24. It was agreed that when requests for republishing articles in journals are received, permission must be obtained from the editor and author, a fee of \$25 will be charged for non-NASAP members and no charge for NASAP members.
- 25. Discussion of new process for D.A. meeting indicated that D.A. members are generally favorable to dividing into the standing committees to carry out work of the Society. There were some suggestions for changing the schedule so that time will be spent more productively and these will be considered further.

# GENERAL ASSEMBLY

The 25th Annual Convention of the Society was opened Saturday morning, May 28, 1977, with remarks by the President, Frank Walton, who summarized the action taken by the D.A. and talked of future plans and concerns. The following items were brought before the General Assembly.

- 1. The audience rose for a few minutes of silence to pay respect to Danica Deutsch, who passed away in December, 1976.
- 2. <u>James McDonough</u> gave his ideas on funding proposals, which had been presented to and approved by the D.A. He will be communicating further with the membership via the Newsletter.
- 3. Helene Papanek suggested two avenues for trying to interest minority groups in NASAP: a) obtaining a black speaker at convention; b) providing scholarships for minority people in each region. (Scholarships were provided at Chicago convention.)
- 4. Tee Dreikurs suggested that a message be sent to Eleanore Redwin, who was unable to attend the convention because of illness, expressing appreciation for her many contributions and cherished devotion to the Society and Individual Psychology.
- 5. <u>ICAASI</u> -- <u>Hal McAbee</u> indicated that there are still openings for the 10th Rudolf Dreikurs Summer Institute to be held at Leeuwenhorst Congress Centre, Holland, July 31 to August 14.
- 6. Acronym -- Carol Arnold announced the proposal for using SAIL (Sharing Adlerian Ideas for Living) as a trial in several groups with the possible adoption at the Washington convention. She indicated that additional volunteers are needed for the P.R. Committee.
- 7. Semi-Annual Meeting, October 28,29,30, 1977 -- Becky McDonough told about plans for this meeting. (Information may be found elsewhere in this NL).

- 9. Richard Berrett announced the need for liaison with the National Council on Family Relations and other national organizations. He asked that volunteers contact him at 3822 N. First, Fresno, CA 93726.
- 10. Father Dayton Salisbury told of his experience as sponsor of Parents Anonymous in Houston and recommended that other individuals consider being a sponsor to groups in their area. The Adlerian approach should be represented with P.A.
- 11. Walton announced that members are invited to serve on any of the committees of NASAP and should contact him at 660 Townes Road, Columbia, S.C. 29210.

# REGIONAL ORGANIZATIONS

Regional meetings were held at the 25th Annual Convention in Chicago. Regions I and IV are already organized with officers. The other three regions decided to organize and chose temporary officers. Reports follow.

# REGION I

Accomplishments of Region I since May, 1976 were reviewed:

- a. Board of Directors formed from four officers and interested persons selected for geographical balance as well as activity.
- b. By-laws formulated, reworked by board by mail, resubmitted to board and adopted.
- c. Region divided into three areas for administrative and activity purposes-Areas A,B, and C. (When NASAP procedures permit in the future delegates to NASAP will be elected by the Region on a ratio of one from each of the three areas and three at large.)
- d. Regional service centers established: book and printed materials sales in Edmonton, CA and Santa Clara, Cal.; tape sale, Corvallis, OR; lending library Adlerian books, Albany, OR; Children: The Challenge book rental, Albany, OR.
- e. Regional newsletter Five issues published from Corvallis; future editing from British Columbia mimeo and mailing from Corvallis.

Election of vice-president and secretary and new board members to be by mail ballot this summer by board to conserve time at the Chicago meeting. Method for membership to nominate and elect is being studied.

Activities of Region for 1977-78 proposed or at least discussed.

- a. Immediately secure credit rating and discounts from publishing houses.
- b. Apply for bulk rate postal mailing permit for newsletter and announcements.
- c. Request Relay to publish articles on how to achieve better community relations and techniques of local promotion and public relations.
- d. Region provide leadership and resources for conferences for both education and business pertaining to the Region either by the Region or by selected areas.
- e. Request that NASAP set aside Friday preceding the Annual Meeting as Regional Day. Part of the day would be devoted to business affairs of the Region, especially the needs and fulfillment of on-going programs of the Region. Part of the day could be devoted to scheduled speakers, demonstrations, etc. in response to desires originating within the Regions. This might include a talk by a top public relations professional or how successful programs were achieved in other Regions. Attendance at these could cross lines by Regions.
- f. Detailed discussion occurred on type and areas for staging conferences this year. Consensus was enthusiastic that meetings occur; that an established group host the area covered; that conference may have to occur with convenient geographical areas with invitations to those further away with strong interests.

It should be noted the 45 members in attendance strongly endorsed direction and efforts of the first year. -- Maurice Bullard, Ch.

# REGION IV

Barney Lane, Chm., indicated that Don Tuites has agreed to draw up By-Laws for Region III. He will draw from this list for the regional meeting scheduled for October 22 and 23. There was considerable discussion about regional boundaries with no specific recommendation.
