#### PRESIDENT'S MESSAGE

#### Dear NASAP Members:

This letter will be devoted to the issue of the 1979 Convention, which is scheduled to be held in Las Vegas, Nevada. I will recapitulate the facts on the matter and briefly summarize the rationale advanced (incompletely I am sure) by those who desire to hold the convention elsewhere and those who think that, given the current situation, it is incumbent upon the Delegate Assembly to hold to the original decision. I urge you to read this letter thoughtfully and carefully.

Bill Marchant, acting on behalf of the Adlerian group in Las Vegas, extended an invitation to the Delegate Assembly, at the semi-annual meeting in Minneapolis in October 1977, to hold the 1979 Convention in Las Vegas. There were no other invitations and the DA accepted the invitation after considerable discussion. The ERA issue did not surface during this discussion. The ERA issue first came to bear on convention sites during the DA meeting at the 1978 Convention this past May. The DA reconsidered the Nevada site for 1979 and reaffirmed its original decision after a thorough discussion. I recall only one negative vote; perhaps there were two. The matter was raised from the floor during the General Assembly at the Convention and a discussion was conducted by then President Walton. A "straw vote" was taken on the issue of boycotting Nevada as a convention site. The vote was 52 against a boycott, thereby upholding the decision made by the Delegate Assembly, and 30 for a boycott.

Several factors weighed heavily on the decision during the course of events.

- 1. APGA had attempted to withdraw its 1979 Las Vegas Convention plans during its 1978 convention in Washington, based on the ERA issue, and had been faced with the distinct possibility of a \$6 million lawsuit should they cancel. This was a fact. APGA is going to hold its 1979 convention in Las Vegas.
- 2. Bill Marchant's group had made reservations with a hotel and the group had proceeded to prepare for the 1979 Convention.
- 3. The Delegate Assembly generally thought that keeping the commitment was vitally important in conducting the affairs of the Society and keeping faith with its members.
- 4. There was no other offer at either the time of the original decision by the DA or at the May Convention when the decision was reaffirmed. Two different groups from California contacted me during July with offers to host the convention. They were asked to remain in a hold pattern for the time being until it would be ascertained if Bill Marchant's group had a firm agreement with the convention hotel. Bill was on vacation at that time and could not be reached. By the time he arrived home, I was in England and did not return until August 16. I telephoned Bill and learned that he had signed a reservation agreement with the hotel. Also, one of the groups withdrew its offer via letter, but one group reaffirmed its offer just prior to the Executive Committee meeting on September 16-17.

You have already read most of the arguments pro and con on the convention site issue in a previous newsletter. I shall only briefly try to recap the major points here.

- 1. Adderian psychologists are supposed to believe in equality. Nevadaians do not and, therefore, we should do our small part via an economic boycott.
- 2. Some communications would accuse the leadership of not believing in equality for women. I don't think that a denial of that point is even necessary.
- 3. Some serious and thoughtful NASAP members have raised the possibility of a serious split occurring in the Society over the issue. That is possible, of course, and I do not mean to underestimate the importance of the issue; however, I have heard personally from fewer than ten NASAP members who were opposed. Three of these were by letter from DA members, one a personal telephone call from a Delegate and one from personal contact. I have had about the same number who support the original decision.

(President's Message cont'd)

I am not of the opinion that democracy and democratic processes of an organization are best served when a minority disagrees with a constitutionally legal action on the part of its governing body and insists on an arbitrary reversal of such decisions.

Many supporters of the decision have raised other cogent questions. You may recall that Gerry Mozdzierz, in has letter to the Editor published in the July Newsletter, suggested that should the Society decide not to have anything to do with non-ERA states, then, the next step would be to move the NASAP office out of Illinois. I support that position. It should be noted also that Chicago hosted two recent conventions, 1974 and 1977, and that Illinois has still not ratified the ERA.

Others have suggested that similar equal rights issues should be considered, i.e., Harold Mosak wrote that perhaps NASAP should not hold conventions in states that permit corporal punishment in the schools or continue to deny de facto rights of blacks and other minorities. That would keep us out of about 40 states. The point is obvious--there are various issues of injustice everywhere and any group espousing any set of values might very well be hard put to find locations that lived up to all of its standards.

Some have suggested that we attempt to positively influence the citizenry of Las Vegas with an educational campaign on the issue as a part of the convention. Perhaps many of you would volunteer to work on such a project.

The Executive Committee, although not empowered to reverse a Delegate Assembly decision, discussed the matter thoroughly (for three hours) during its September 16-17 meeting in Chicago. No action was taken, which left the matter as it stands. In the meantime, Bill Marchant's group is proceeding nicely in the planning of the 1979 Convention. Let us heartily support their efforts and, be assured, that the ERA matter will most certainly enter into deliberations when future convention sites are selected.

Perhaps we should also remember that NASAP is NOT just a United States organization -- it is an international organization -- many Canadian and European members. And, there is a distinct legal question as to whether the Society can become involved in political issues. Certainly, the means by which advocacy of any issue can be effectively carried out, is a problem for immediate resolution by the Society.

# Honolulu, Hawaii 8-24-78

The current discussion re the Las Vegas convention is distressing to many such as myself who want harmony in NASAP, and who see all the various points of view as legitimate.

It appears to me that we as Adlerians can change "problems into opportunities." Here are some personal views:

- 1. Adderians are strong on equality, and undoubtedly our elected leadership reflects this point of view, and their selection of the Las Vegas site and keeping to it, means that they consciously, knowingly, keeping all issues in mind, male and female members, voted a certain way. We should show confidence in our leadership and support them even if they should have made an error.
- 2. Adderians who disapprove of Nevada's vote should not boycott the convention, thereby engendering divisive feelings within the NASAP group, especially since no Adderian is anti-ERA.
- 3. Group and individual protests can be made known to Nevada citizens through newspaper articles, etc., but these are likely to have a backlash effect on the basis of "Who are these --- to tell us how to run our state?"
- 4. We might want to get in touch with pro-ERA individuals and groups in Nevada to find out what, if anything, we can do about helping them.

In the meantime, I suppose we should regard politics as the art of the possible, and adjust our idealism to practicalities. I am personally not one who favors such behavior generally, but for the good of NASAP this is what I would advise all Adlerians.

# Columbia, S.C. 9-18-78

As a member of NASAP and the Columbia (SC) Adlerian Society, I strongly protest holding the NASAP convention in Las Vegas.

Nevada has not seen fit to make all of its citizens first class in that the ERA has not been passed in that state. The ERA simply states that

"Equality of rights under the law shall not be denied or abridged by the U.S. or any state on account of sex."

For an organization whose cornerstone is equality for children, men, and women--all persons to meet in a state where neither women nor men have equality of rights under the law is incongruent.

Perhaps a contract has been signed; perhaps a loss of revenue is involved. Consider, however, the loss of revenue that unequally paid women have suffered-not to mention insurance, social security and credit losses over the years.

If NASAP stands for equality, let it make a stand publicly and let it speak to Las Vegas in the financial terms it understands—NASAP should boycott Nevada!

It would be my hope that with continued efforts we could offer every community within the midwest region available information and materials for establishing, organizing, staffing and funding family education centers and parent study groups. I would anticipate that several workshops presented by knowledgeable Adlerians on such topics as Adult-Child Relationships, Family Life, Three Life Tasks, Juvenile Delinquency, Child Abuse, Death and Dying, etc. would be well received by people not already familiar with Dreikurs' and Adler's ideas. These comments represent only a few ideas and hopes and aspirations for the coming 1978-79 NASAP year. Continued support, encouragement and regional action are contributions required by all NASAP members of Region II.

# EXECUTIVE COMMITTEE MEETING

The Executive Committee met on September 16 and 17 in Chicago. The major part of the meeting was spent on finances and the 1979 Annual Convention site. In his President's Message in this NL, Hal reports on the Executive Committee's discussion of the Las Vegas meeting. Other items included:

- Looked over Washington convention report and made various suggestions to be passed on to the Workshop/Convention Committee and to future hosts.
- Reworked the 1978 budget and set priorities for the remainder of the year.
- Recommended a dues increase for approval by the D.A. The increase was recommended because of cost of inflation over the past three years as well as increase in costs due to a larger membership and additional services being provided.
- Recommended the establishment of a Task Force on Minorities with the charge to develop means and strategies to involve persons from various minority groups in the work and membership of the Society.

#### APPEAL FOR FUNDS

In round figures, the income for 1978 is projected
